



Customer Agreement

For the purposes of this agreement, the term "pet" shall be understood to mean one or more animals left in the care of Soos Creek Kennels(SCK) and belonging to the undersigned customer of Soos Creek Kennels(SCK). Soos Creek Kennels is a Freedom Creek LLC company.

Please Initial on the line next to each number below.

1. _____ I certify that I am the legal owner of the pet that I am leaving in the care of SCK.
2. _____ I understand that I am solely responsible for any harm to persons or animals or any property damage caused by my pet while in the care of SCK.
3. _____ I understand and agree that in admitting my pet to doggie daycare, SCK has relied on my representation that my pet is in good health, has received all vaccinations and test results required by SCK (an updated record will be provided when new vaccinations are administered) and has not shown aggression or threatening behavior towards any person or any other pet.
4. _____ I understand the risks involved in "free play" at SCK and accept that injuries may result from such activity. I further understand and agree that SCK and its staff will not be liable for any problems that develop with my pet, provided reasonable care and precautions are followed, and I hereby release them from any liability, including but not limited to, loss or damage due to disease, death, escape, theft, fire, fight, injury to persons, other pets or property, or other unavoidable causes, arising from my pet's stay at SCK.
5. _____ I understand and agree that any problem that develops with my pet will be treated as deemed best by the staff of SCK in their sole discretion, and that I assume full financial responsibility for any and all expenses involved.
6. _____ I understand and authorize immediate veterinary attention, in the judgment of the staff of SCK, should a problem develop with my pet. In the event that SCK, after reasonable effort, cannot contact me about such a problem with my pet, I authorize veterinary attention of my pet up to the projected financial cost of \$_____.00. I request, if the projected financial cost exceeds this amount, that continued attempts be made to reach me for further instruction. Should emergency care exceed this amount I release SCK and the veterinarian of choice from any liability. (Note: The primary veterinarian used by SCK is Blue Pearl.
7. _____ I agree to pay the rate for daycare in effect on the date the pet is checked into SCK. Prices are subject to change at any time, without notice. No pets will be allowed to return until all charges (including advances for medical costs) are paid in full.

8. _____ I agree that my pet will be picked up from daycare by me or a pre-approved agent by 6:00 PM, unless prior arrangements have been made. I also understand that late charges will be imposed for late pickup. I agree that arriving for pickup after 6:00 PM will result in a charge of a set late fee of \$15.00 covering up to the first 15 minutes. I will be charged an additional \$1.00 per minute for every minute thereafter.
9. _____ I agree that my pet may be videotaped, photographed and recorded. SCK shall be the exclusive ownership of the results and all proceeds of such tapings, photography and recordings. SCK may use the video, photography and recordings for an unlimited number of times in perpetuity, to copyright, and to use and license to others in any manner I further agree that my pet may be used in any and all media and in the promotion, advertising, sale, publicizing of SCK.
10. _____ SCK reserves the right to refuse any pet.
